3. WHY DO WE COLLECT THIS INFORMATION & HOW WILL IT BE USED?

Your details are required in order to deliver (through the Red Balloon Family Foundation) services to young people within our district to develop and support emotional health and wellbeing (MiLife project). Delivered to all state secondary schools within the district.

The information that you have provided will be securely held by the Council and will only be accessed by authorised persons with the appropriate access controls. The Council will only use the information that you have provided for the purpose above and will not use it for any other purpose, unless you have given your consent, or this is otherwise required or permitted by law.

4. WHAT IS THE LEGAL BASIS FOR PROCESSING YOUR PERSONAL DATA?

6(1)(a) Consent. The data subject has given clear consent for the processing of their personal data for a specific purpose. The data subject has given explicit consent to the processing.
