2. WHAT PERSONAL DATA DO WE COLLECT ABOUT YOU?

Name, address, telephone number, email address.

3. WHY DO WE COLLECT THIS INFORMATION & HOW WILL IT BE USED?

Your details are required in order to record objects deposited by the legal owners as a record that legal title to items in our collection was passed to us and so that depositors can be contacted when items on temporary deposit are ready for return and so that donors can be contacted for more information or in case of risk to the object(s).

The information that you have provided will be securely held by the Council and will only be accessed by authorised persons with the appropriate access controls. The Council will only use the information that you have provided for the purpose above and will not use it for any other purpose, unless you have given your consent, or this is otherwise required or permitted by law.

4. WHAT IS THE LEGAL BASIS FOR PROCESSING YOUR PERSONAL DATA?

6(1)(a) Consent. The data subject has given clear consent for the processing of their personal data for a specific purpose. The data subject has given explicit consent to the processing.
