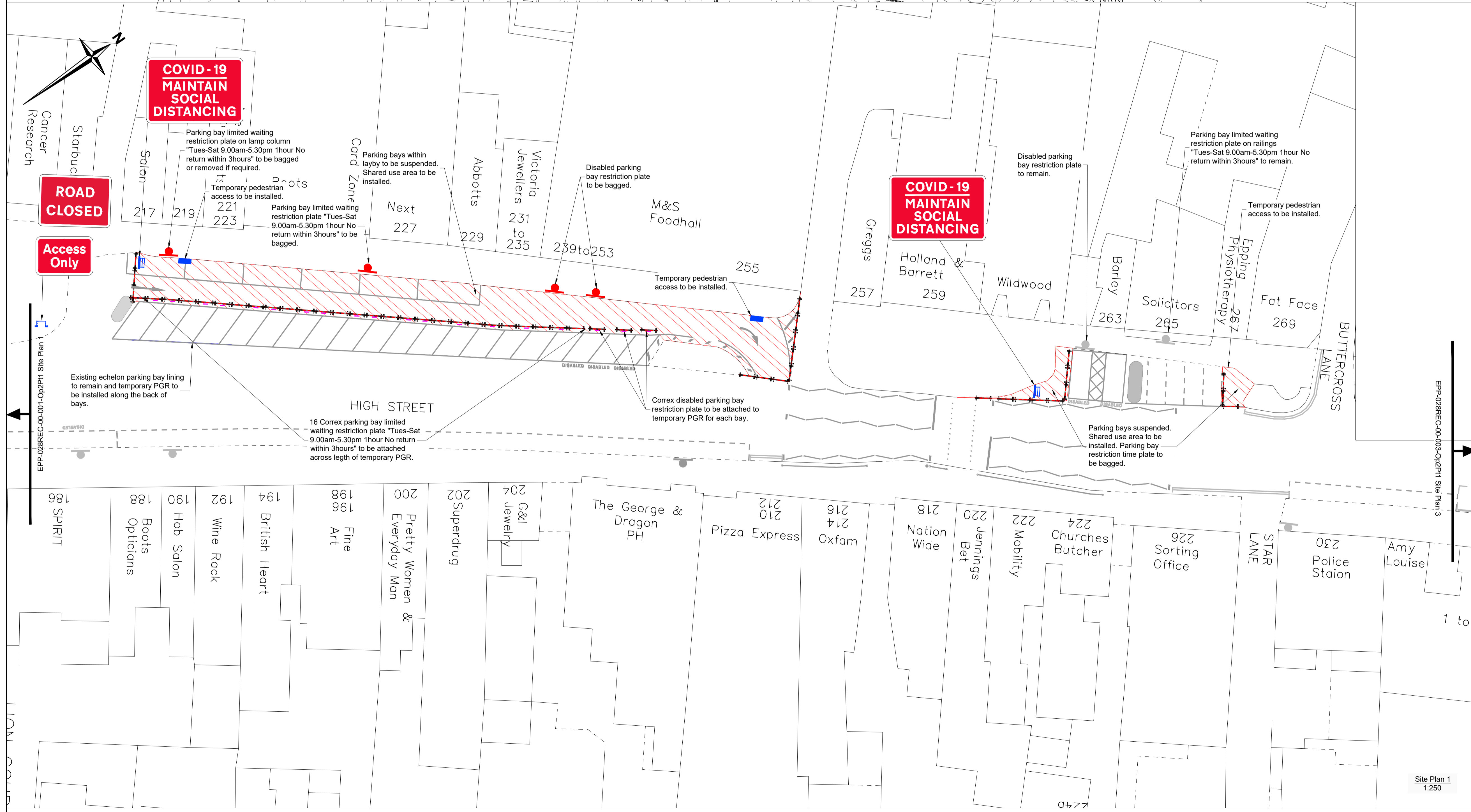


**Safer, Greener, Healthier Sign Detail**  
 Sign to be installed throughout scheme area to highlight distancing in new shared spaces.

- Notes**
- Do not scale. This drawing is to be read in conjunction with all other contract drawings and documents.
  - All works to be in accordance with the Department of Transport Specification for Highway Works and Essex County Council Specifications and Standard Construction Drawings.
  - The positions of apparatus given on this drawing are as shown on drawings supplied by Statutory Undertakers and are intended as a guide only, without guarantee of their exact position, extent or presence. The Contractor shall ascertain from the Statutory Undertakers, exact details, including service connections to properties.
  - Pedestrian barrier to be used to segregate foot and vehicle traffic.
  - Drop kerb and tactile crossing points to be used at all times.
  - Road markings to be altered to suit TM install.
  - All dimensions are in metres unless otherwise stated.
  - All TM to comply with TSM Chapter 8 and Safety at Street Works and Roadwork's act.
  - All road markings and signs to be comply to TSRGD 2016.
  - All minimum safety zones to be met at all times.
  - TM drawings to be checked for suitability by foreman/supervisor before installation.
  - One height and spacing in line with Ringway Jacobs Policy.
  - Sandbags to secure signage throughout.
  - Any PGR/Cycle Stands & street furniture that are removed ground to be made good similar to existing.
  - Drawing to be read in conjunction with EPP-028REC-00-001-Op2Pt1, EPP-028REC-00-003-Op2Pt1 & EPP-028REC-00-004
