### 3. WHY DO WE COLLECT THIS INFORMATION & HOW WILL IT BE USED?

Your details are required in order to ensure appropriate consent to use of images and footage for marketing purposes as outlined in the EFDC photo and filming consent form you would have been asked to complete when the photos/footage was taken..

The information that you have provided will be securely held by the Council and will only be accessed by authorised persons with the appropriate access controls. The Council will only use the information that you have provided for the purpose above and will not use it for any other purpose, unless you have given your consent, or this is otherwise required or permitted by law.

#### 4. WHAT IS THE LEGAL BASIS FOR PROCESSING YOUR PERSONAL DATA?
